

Resolved unanimously that he be directed to lay out city lots on the Southwest side of the river Muskingum, beginning where the north side of the two acre tract appropriated to make good the fractional city lots shall end, after leaving a sufficient space for a street, thence going up said river as far as he may find land suitable for the purpose, leaving a sufficient street along the banks of said river; and also leaving convenient avenues or streets from the river back to the hill.

Resolved that he lay out as many house lots as the land may be suitable for on both sides of the highway leading from the river near Fort Harman west being two chains and seventy two links deep on the north and four chains deep on the south side of said highway.

All the aforesaid lots are to be of the same size or quantity with the house or city lots already laid out in Marietta.

Resolved unanimously that the Superintendent next proceed to lay out as many house lots as the land may be suitable for on each side of the mouth of the river Hockhocking agreeably to a survey made for the purpose. The quantity of land to be assigned to each of those lots shall be half an acre on both sides of the river. The streets to be one chain wide.

Resolved unanimously that he then proceed to lay out the residue of the house lots opposite to the mouth of the Great Kenhawa on such particular spot as shall be most eligible for this purpose. The quantity of land to be assigned to these house lots shall be half an acre to each, and the streets one chain wide.

Resolved unanimously that the Superintendent proceed to lay out as many eight acre lots as may be still wanting to complete the number to eight hundred & seventeen from the land unappropriated in the eighth and ninth Ranges not hereinafter appropriated for one hundred & sixty acre lots.

Resolved that he be also directed to appropriate the land for eight acre lots which appears to be an excess in the rectified survey of a tract of land called Virgins bottoms. After this he will proceed to lay out the residue on the Ohio in the tenth range & in the vicinity of the two Villages proposed to be laid out at the mouth of the Hockhocking river and opposite to the mouth of the Great Kenhawa.

Resolved unanimously that all the unappropriated land within the eighth, ninth & tenth ranges proper for one hundred & sixty acre lots & the fractional parts of Townships eight & nine in the eleventh Range, except what has been designated for fifth division lots, be laid out for that purpose. And that the Superintendent proceed to make up the deficiency out of the fractional lots proper for that purpose, lying on the river Ohio, reserving such tracts as may be proper, to form into fifth division lots.

Resolved unanimously that Edward Harris, Esq. Col. John Mawney and Charles Greene, Esquire be a committee to sell the four block houses at Campus Martins, either at private or public sale as they may judge proper. And said committee are directed to release the ground on which they stand, with the same privileges of the yard as other houses in the square now posers. And said committee are directed to release with blockhouse no. two the lands which have heretofore been assigned to it for a garden.

Resolved unanimously that said committee give due notice & sell the three garden lots attached to the Blockhouses no. one, no. three and no. four at public auction.
