ORDINANCE NO. 18
1957

ACCEPTING APPLICATION FOR ANNEXATION OF TERRITORY.

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF LOGAN, STATE OF OHIO: -

Section 1. That the application of Mrs. Grace B. McNeil and others for the annexation of the following described territory in the County of Hocking and adjacent to the City of Logan, Ohio, to-wit:

Beginning at the intersection of the center line of Norwood Avenue and the south line of Front Street (State Highway No. 33); thence southeasterly with the south right-of-way line of State Highway No. 33 to the west right-of-way line of the Union Furnace Road (State Highway No. 328); thence south with the west right-of-way line of State Highway No. 328 to the south right-of-way line of the C. & O.
