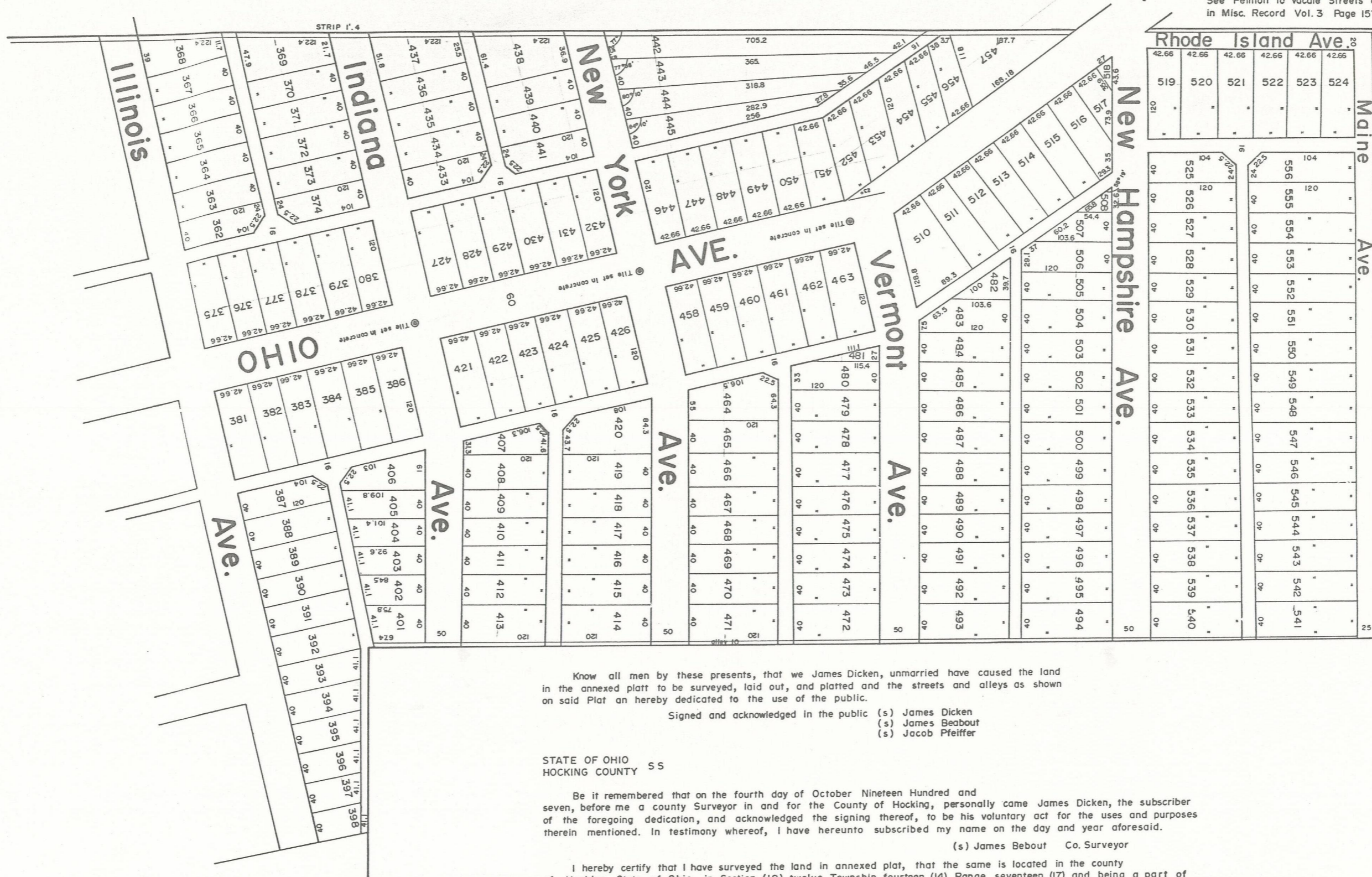

Be it remembered that on the fourth day of October Nineteen Hundred and seven, before me a County Surveyor in and for the County of Hocking, personally came James Dicken, the subscriber of the foregoing dedication, and acknowledged the signing thereof, to be his voluntary act for the uses and purposes therein mentioned. In testimony whereof, I have hereunto subscribed my name on the day and year aforesaid.

I hereby certify that I have surveyed the land in annexed plat, that the same is located in the county of Hocking, State of Ohio, in Section (12) twelve Township fourteen (14) Range seventeen (17) and being a part of the NE 1/4 of said section. Beginning at the S.E. corner of said quarter section, thence West thirty four and three hundredths (34.03) chains, to the H.V.Ry. thence N 75° E. five and thirty eight hundredths (5.38) chains. Thence E twenty eight & twenty hundredths (28.20) chains, thence South three and fifty six hundredths (3.56) chains to beginning and containing (10.46) acres and known as Lot Six (6). In proceedings of the court of Common Pleas of Hocking Co. to partition the Estate of William Wright Deceased Vol. 19.

Also Lot five (5) (Wright Addition) in N.E. 1/4 of same section beginning at a point on South Line of said 1/4 Sec. Intersection of said South line and center line of H.V.Ry., thence N 75° E five and thirty eight hundredths (5.38) chains thence N one and eighty one hundredths (1.81) chains, Thence E twenty eight and twenty hundredths (28.20) chains, Thence N twelve and eighteen hundredths (12.18) chains Thence West twenty seven and ten hundredths (27.10) chains, Thence S 22 1/2° W sixteen and sixty four (16.64) hundredths chains to beginning and containing thirty four and seventeen hundredths (34.17) acres.
