**Situation.**

near the falls of the Rock Hocking River in the County of Hocking and State of Ohio - Laid out by Thomas Worthington July, 1816

**Description.**

Main Street is five poles wide and runs East - Second and Front streets are four poles wide and run East, - Market Street is 5 poles wide and runs North, High, Spring, Mulberry and Walnut streets are 4 poles wide and run North - The alleys are all one pole wide, four run North and three run East. The public square is 6 poles long and 2 1/2 poles wide, The Market Square is 9 poles long and 2 1/2 poles wide - The In Lots are all 9 poles long and 4 1/2 poles wide except Nos 48, 49, 50 and 51, which are 7 poles long: The Out Lots are all 12 poles wide and from North to South and from 25 to 26 poles long from East to West, Market Street through the out lots is three poles wide and runs North Walnut Street two poles North 30 W. and East Street two poles and runs N. W.

Out Lots Nos 12 and 27 given by the proprietor to the inhabitants of the Town of Logan for the following purposes, viz: Out Lot 12 for the use of schools, and Out Lot 27 for a burying ground and for no other use or purpose whatsoever.
