Vickers appeared as Attorney for Columbus Hocking Coal and Iron Co. as opposed to said corporation and Seth Weldy appeared as Attorney for said Petitioners. The Board after hearing the arguments of said Attorneys Pro and Con in the matter and after a careful examination of the petition and the law pertaining to the creation of Village, do find that the petition contains all the matter required, that its statements are true, that the name proposed is appropriate, that the limits of the proposed Corporation are accurately described and are not unreasonably large or small, that the map or plat is accurate; that the persons whose names are subscribed to the petition are electors residing on the territory, that notices have been served as required; that there is requisite population, for the proposed corporation; the Board thereupon deem it proper and right that the prayer of the petition be granted and do hereby direct the Auditor to enter the proceedings to that effect on the Journal also to prepare a transcript of the same for the County Recorder. 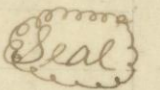

Copy of Notice. A Notice is hereby given that on the 2nd day of December, 1890, the agents heretofore duly appointed by the petitioners, presented to and filed with the Board of Commissioners of Hocking County, Ohio, at a regular session of said Board, a petition setting forth that the rigours thereof are electors of the territory therein described, containing about four hundred and forty-nine inhabitants, that a part of said territory is already laid out in
