The Board of Commissioners of Hocking County, Ohio, met this day pursuant to adjournment, present George Marks President, John S. Nutter and Henry Trimmer,

In the matter of the annexation of certain contiguous territory to the corporate limits of the Village of Logan, Ohio; This day the matter of the petitions of the Citizens and Corporate authorities of the Village of Logan, praying for the annexation of certain contiguous territory of the corporate limits of said Village, came on to be heard and examined by the Commissioners, and thereupon came Wm. P. Price Village Solicitor representing said Village, and John F. White Esq representing certain owners of lands proposed to be annexed and agreed that the hearing and examination of said matter might be continued until Wednesday, November 14th 1888, and thereupon said hearing and examination was continued by said Commissioners until said 14th day of November 1888.

The Board of Commissioners of Hocking County Ohio, met this day pursuant to adjournment present George Marks President, John S. Nutter and Henry Trimmer,

In the matter of the annexation of certain contiguous territory to the corporate limits of the Village of Logan, Ohio.

This day in pursuance of the continuance of Wednesday Nov. 7th 1888, the matter of the petition of the citizens and Corporate Authorities of the Village of Logan, praying for the annexation of certain contiguous territory to the corporate limits of said Village, came on to be heard and examined by the Commissioners, and thereupon came Wm. P. Price representing the incorporated Village of Logan as its duly authorized Solicitor and John F. White representing L. A. Culver Maynard Pond and James Little interested parties on their own behalf, and the Commissioners having heard all the evidence offered on behalf of said Village, and also on behalf of said interested parties and having heard the arguments of the Council and being fully advised in the premises do find that said petition contains all the matters required by law, that the limits of the territory proposed to be annexed are accurately described; that the plat attached to said petition is accurate; that due legal notice has been given, as required by publication, and that a copy of said notice, was posted on said territory more than six weeks prior to the time first fixed for the hearing of said petition.

Said Commissioners further find, after careful consideration of said matter that the limits of the territory contiguous to said Village of Logan proposed to be annexed thereto are unreasonable in extent and in their opinion it is not right that the prayer of said petitioners be granted as to the entire territory described, but it seems to them right that the prayer of said petitioners be granted in part and as to such portion of the territory described in said petition and being and lying contiguous to said Village as described as follows, to wit:

Being a part of Section No. 11, Township No. 14, Range No 17, Beginning at a stone at the N.E. corner of fractional lot No 77, in said Section, Township and range thence by the present corporation line of the Village of Logan S 1° W 7.08 chains, thence S 89° E 14.44 $\frac{1}{2}$ chains, thence S 1° W 3. chains, thence S 89° E 3.00 chains S 1° W 2.61 chains thence S 89° E 16.75 chains, thence N 1° E 9.42 chains thence S 89° E 4.87 $\frac{1}{2}$ chains, thence N 1° E 3.28 chains, thence S 89° 25' W 39.07 chains to beginning containing 32.77 acres, more or less. Therefore the Commissioners grant the prayer of said petitioners as to so much of the territory proposed to be annexed and described therein as is above set out and described, and give their consent and order that so much of said territory as is
