

# LAURELVILLE,

## Proceedings for Incorporation.

Office of the Commissioners of Hocking County State of Ohio:

Logan, Ohio, Monday March, 4, 1889.

The Board of County Commissioners of Hocking County, O. met this day in regular quarterly session; Present, Henry Trimmer, Pres., John F. Kutter and George Marks, also W. M. Bowen, Auditor.

In the matter of the petition of J. B. Risson and others, for the Incorporation of Laurelville, Perry Township, O. as a village the following petition was this day presented to the Board.

**Petition:** To the Honorable Board of Commissioners of Hocking County Ohio: We the undersigned represent to your honorable body, that we are electors of the territory hereinafter described, that said territory contains about two-hundred and fifty inhabitants, that a part of said territory <sup>hereinafter</sup> <sup>described</sup> is laid out in town lots and that a plat of said lots is lawfully acknowledged and is known as the Village of Laurelville; and we further represent that for the better regulation, government and improvement of said Village it is necessary that it should be Incorporated.

That the territory included in the following described tract and not laid out in town lots is adjacent to said lots and should be included in the limits of the incorporate bounds of said Village.

We therefore pray your honorable Board to grant an order of Incorporation of the following described territory, (a correct Map of which is herewith filed and marked exhibit "A") situate in the Township of Perry, county of Hocking, State of Ohio, and bounded as follows to wit:

Beginning at the South West corner of Section No 31, Township No 12, Range No 19; Thence East with the section line 29 poles to a stake in the quarter section line; Thence north in said section 80 Poles to a stake in the quarter section line; Thence west with the quarter section line 49 Poles to N E corner of the SW quarter of the SW quarter of said Section No 31; Thence North with the quarter section line 154 poles to a stake in said line; Thence west 80 poles to a stone in the section and range line to the NW corner of Mary A Dodsons ten acre lot; thence south with the range line 234 poles to the point of beginning, containing 141 1/2 acres more or less. That the before described territory be incorporated as a Village and that the name of said village be "The Incorporated Village of Laurelville; and we hereby appoint J. B. Risson and W. G. Dawson our agents to present this petition to your Honorable Body. February 28, A.D. 1889.
