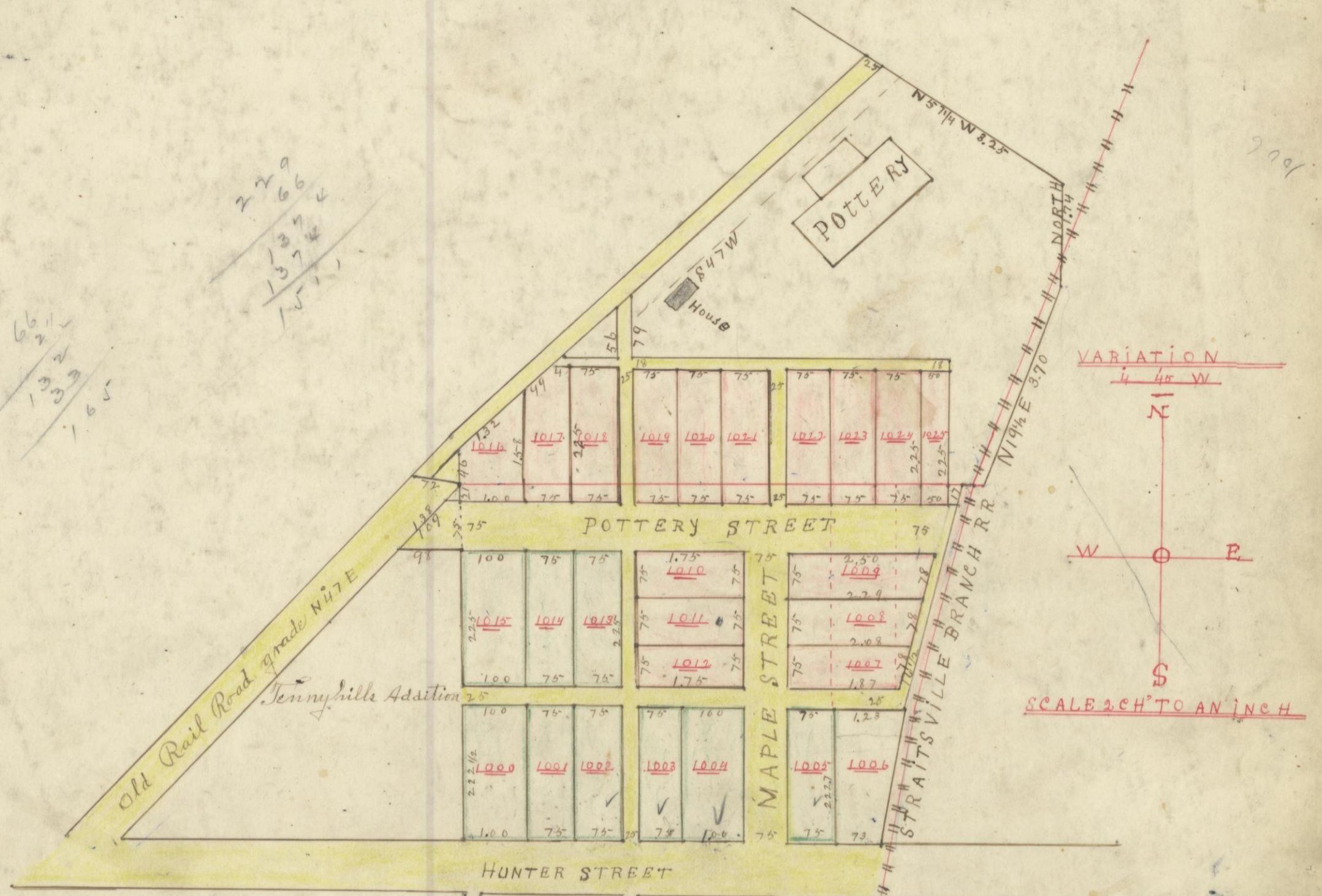


THE LOGAN POTTERY CO. ADDITION



I certify the foregoing to be a correct Plat of the Logan Pottery Company Addition to the Village of Logan,ocking County, Ohio, being a part of Fractional Lot No. 7, Section 12, Township 15 N., Range 17 W.,ocking County, Ohio, beginning at the South West corner of said Lot, thence East 6.73 Ch. to the West line of the Right of way of the Straitsville Branch of the C. H. V. R. thence by the West line of said R. W. to the East line of said Lot, thence North 1.73 Ch. to the North East corner of said Lot, thence West 6.97 Ch. to the North West corner of said Lot, thence South 5.67 1/2 Ch. to Beginning, containing 3.93 acres, also a part of Fractional Lot No. 6, Same Section Beginning at the North West corner of said Lot, thence South 4.67 Ch. to the Right of way of the Straitsville Branch of the C. H. V. R. thence by the West line of said Right of way, to the North line of said Lot, thence West 1.24 Ch. to Beginning, containing 3.00 acres, also a part of Fractional Lot No. 9, Same Section Beginning at the South West corner of said Lot, thence East 8.00 Ch. thence North 2.23 Ch. thence West 6.29 Ch. thence South 4.72 Ch. thence South 4.6 Ch. to Beginning, containing 1.59 acres, all of said several tracts situated to contain 5.83 acres, said tracts contain 26 lots, as designated by the Plat.
