

Genova Addition to Logan, Ohio.

Description: Being a part of a 26.2 Acre tract, known as the Mary Dye lands, situate in the $N\frac{1}{2}$ of ^{SW 1/4 of} Sec. 11, Tp. 14, Range 17, Falls Tp, Hocking County, Ohio; - Beginning at a stone at the S. E. cor, thereof; witness, White Elm 4" diameter $N. 80^{\circ} W. 33$ feet; thence $N. 1^{\circ} 33' E.$ with old Corporation line 757 feet; thence $N. 87^{\circ} W. 339.4$ feet to an iron pin; thence $N. 1^{\circ} 33' E.$ parallel with Corporation line 221.5 feet to an iron pin; thence $N. 78^{\circ} 20' W. 763.9$ to an iron pin; thence $S. 1^{\circ} 56' W. 921$ feet to an iron pin on the N. line of Hunter Street; thence $S. 78^{\circ} E. 1114.5$ feet to place of beginning, containing 21.73 Acres.
