DLZ

Gary Silcott from DLZ provides the Commissioners with an update on the following projects; Murray City, Carbon Hill, Union Furnace, Enterprise/664, HVST, and West Street.

Commissioner Ogle discussed the decrease in loan payments if projects come in under budget. Ogle asked Silcott if TAM will need an extension, Gary said not at this time.

Commissioner Waugh asked for a brief explanation for the troubles with Xpress. Gary Silcott said that there is a lateral that can't be found on Long Street, and Xpress gave up looking and says they can't find it. The contract says they have to find it.

Commissioner Ogle discussed the french drain in Murray. The Mayor has had a few discussions with Gary Silcott, and he says that he told the Mayor that this problem has nothing to do with the sewer project.

Commissioner Dickerson replied that the Inspire Shelter has a very strict schedule and policy. They are housed there overnight, a course of a few nights if needed, but at 7:00 a.m. they eat and are out the door. Sue asked if the Inspire shelter could help these individuals with the transition into a job and housing. Commissioners and Deb Tobin from Hocking Times discussed that some of these individuals don't want help, they prefer their current lifestyle. Commissioner Ogle knows that Inspire shelter has helped a family with bus fare to get them to loved ones who could help them establish themselves.
