Sundy Creek Horizon

Sam Tuten, Sunday Creek Horizons Director of Local Government Services, discusses with the Commissioners the Appalachian Community Grant that DeWine has recently announced. Mr. Tuten explains what the process is expected to look like, applicants, possible projects, etc. Logan Hocking School has contracted Sunday Creek's service. Commissioner Ogle discusses some potential projects the Board would like put on the table, if applicable. Monte Bainter, LHSD Superintendent states that everyone has to work together or they won't have a chance to obtain this funding. The Board agrees that they are interested in the downtown revitalization, and would like to support this moving forward. Monte expresses that he wants to make sure that all of the entities work together, and work as one. Guidance is anticipated to drop very soon.
