Don Kempton asked the Commissioners why the townships do not get annual reports each year of the delinquent taxes on properties each year. Commissioners replied that he can call in and ask for one, and that it might not be a requirement for Diane Sargent to send one out to each township. Kempton and Commissioners discussed the upcoming school, potential empty buildings that could be in use, and locations of the building. Mr. Kempton asked the commissioners if they have any opinions or suggestions to help get more revenue for their township.
