Mike Nihiser voiced his concerns about spending millions of dollars on a sewer system in Rockbridge that didn't help that much, plus adding that residents are now getting charged water and sewer bills with sewer backing up into homes in Rockbridge when there is a flood. He also voiced his concerns of spending 10 million dollars for a sewer system in Haydenville because a developer wants to put in a gas station. He feels that the Rockbridge Sewer system just benefits one developer and several landowners that benefit from the public Grant money. Mr Nihiser also stated that the situation on Bradford Drive, when the mechanical system fails, raw sewage goes into the stream and across the road through the High School property. He feels this needs to be addressed.
