Therefore it is no longer a "subdivision" and the Planning Commission has no control.

There were three items of new business.

1.) George Seymour questioned how he should proceed to divide a parcel which is landlocked. The owner has used the railroad right of way as access for years, however there is no recorded easement.

Shaw suggested that a "recorded" easement would have to be obtained before the Planning Commission should consider splits. No action was taken.

Landlacked Ac.

Mike Berry, representing Bob Cassidy, requested a variance to allow the split of a 5 acre tract from his 92.7 acre parent tract in Section 32, Falls Township. Access would be by a 60' easement from S.R. 664.

> Bob Daubenmier moved to grant the variance, Gene Dennis 2nd, Vote unanimous

3.) Frank Postel presented the commission with several sketches showing the division of his 40 acre parcel in Section 18 Good Hope Township. All tracts would be greater than 5 acres.

Shaw suggested that if all lots had at least 60' of public road frontage, it would be a subdivision and would not need Planning Commission approval.

Mr. Postel thought this would be the way to go and will discuss it with his surveyor. He will return to the Planning Commission if necessary.


