Thence leaving the south line of the north-half of Section 36 and along the easterly right of way of what was known as The Hocking Valley Railway Company, with a curve to the left having a RADIUS of 1482.40, ARC LENGTH of 350.88, DELTA ANGLE of 13° 33' 42" and a CHORD BEARING and DISTANCE of North 32° 30' 38" West, 350.06 feet to a point in Monday Creek;

Thence leaving the easterly right of way of what was known as The Hocking Valley Railway Company and with a line through the grantor's property, North 59° 09' 44" East, passing 5/8" iron pins with 1-1/4" plastic identification caps set at 75.00 feet and 1352.51 feet, going a total distance of 1382.51 feet to a 5/8" x 10" iron pin set in the center of Tucker Road (Township Road 383 / unmaintained);

Thence along the center of Tucker Road (Township Road 383 / unmaintained) the following five (5) courses:

- 1. South 12° 49' 09" East a distance of 86.94 feet to a point,
- 2. South 19° 44' 21" East a distance of 114.39 feet to a point,
- 3. South 28° 54' 26" East a distance of 100.75 feet to a point,
 4. South 47° 49' 14" East a distance of 96.17 feet to a point, and;
- 5. South 88° 59' 50" East a distance of 36.62 feet to a 5/8" iron pin with a 1-1/4" plastic identification cap set on the east line of the southwest quarter of the northeast quarter of Section 36, said iron pin being on the west line of a 72.94 acre tract (Deed Volume 91, Page 81 / United States of America);

Thence leaving the center of Tucker Road (Township Road 383 / unmaintained) and along the east line of the southwest quarter of the northeast quarter of Section 36, South 03° 45' 38" West, passing a 5/8" iron pin with a 1-1/4" plastic identification cap set at 30.00 feet, going a total distance of 734.59 feet to the place of beginning, containing 21.423 acres more or less and being subject to the right of way of Tucker Road (Township Roa 383 / unmaintained) and all other legal easements of record.

All iron pins set being 5/8" x 30" with a 1-1/4" plastic identification cap stamped "SHARRETT 8019".

Bearings are based on GPS observations taken on May 10, 2024 using the Ohio State Plane Coordinate System – Zone South (NAD83) and are to be used to denote angles only.
