

DESCRIPTION OF SURVEY FOR DAVID EAVES

Being a part of a tract of land last transferred to Wayne Schaal in Vol. 114, Pg. 600, Hocking Co. Deed Records, situated in the north half of Sec. 16, Perry Twp., T-12N, R-19W, Hocking Co., Ohio, and being more particularly described as follows:

Beginning at an iron pin set on the west line of Sec. 16, said pin being the NW corner of said Schaal tract and is referenced by the NW corner of said Sec. 16 which bears, by previous survey, North a distance of 888.36 ft.;

Thence, with the north line of said Schaal tract and along an existing fence, S 89° 10' 45" E a distance of 1138.69 ft. to a spike nail found in the center of Co. Rd. No. 7 (Middle Fork Rd.);

Thence, with the center of said Co. Rd. No. 7 the following three (3) courses:

- 1) S 0° 55' 45" E a distance of 613.14 ft. to a point;
- 2) S 4° 48' 21" W a distance of 124.27 ft. to a point;
- 3) S 13° 14' 24" W a distance of 168.95 ft. to a point;

Thence, leaving Co. Rd. No. 7 and with the north line of an 81.33 acre tract described in Vol. 150, Pg. 076, N 89° 39' 34" W, passing an iron pin set at 31.84 ft., going a total distance of 1099.43 ft. to an iron pin set on the west line of Sec. 16;

Thence, with said west line, North a distance of 911.12 ft. to the place of beginning, containing 23.6989 acres, more or less, and being subject to the right-of-way of Co. Rd. No 7 and all valid easements.

Cited bearings are based on the west line of Sec. 16 as running due North & South.
