**BILL KAEPPNER:** Hocking County resident Bill Kaeppner asked the Commissioners about delinquent taxes and at what point is reconciliation pursued. They added that the Treasurer did mention that she was working on taking care of ones that she can and suggested Bill speak with her.

JUDGE WALLACE-PARKING LOT VANDALISM: Judge Wallace addressed his concerns about the courthouse parking lot. He informed the Commissioners that there have been several acts of vandalism to vehicles belonging to his probation staff. He would like to see cameras installed and offered some funds that he has available. He added that he has inquired about funds from EMA that may be used for parking lot cameras. He said that the cameras would cost approximately \$8,000. John suggested that he and Judge Wallace meet with the Sheriff because he is in charge of courthouse security.

<u>MEMO TO DEPARTMENTS ON MAINTENANCE REQUESTS</u>: The Commissioners discussed sending a memo to all departments asking to email the commissioners office with maintenance requests in order to keep track of items that need addressed and organized them in order of need.

**J&FS MEDICAL TRAVEL:** Motion by Sandy Ogle and seconded by John Walker to pass a resolution that the staff of Hocking County Department of Job & Family Services have approval to travel out of the county to transport clients to medical appointments. The HCDJFS will not be required to obtain prior approval for each individual transport. Vote: Ogle, yea, Walker, yea.

#### AMENDMENT TO SUBGRANT AGREEMENT-J&FS AND CHILDREN SERVICES-ADULT PROTECTIVE

**SERVICES:** Motion by Sandy Ogle and seconded by John Walker to approve the Amendment to Subgrant Agreement between Hocking County Department of Job & Family Services and Hocking County Children Services Board for Title XX-Adult Protective Services with the following sentences are eliminated from Paragraph 7, Payment for Purchased Services: Invoices shall be prepared using ODHS 1810. The ODHS 1001 shall also be submitted with each invoice, with the amendment retroactive to July 1, 2009. Vote: Ogle, yea, Walker, yea.

#### AMENDMENT TO PURCHASE OF SERVICE CONTRACT- J&FS AND CHILDREN SERVICES-NON-

**EMERGENCY TRANSPORTATION:** Motion by Sandy Ogle and seconded by John Walker to approve the Amendment to Purchase of Service Contract between Hocking County Department of Job & Family Services and Hocking County Children Services Board for Title XIX-Non-Emergency Transportation with the first sentence of Paragraph 3, Availability of Funds, to be amended as follows: Total dollar value of this contract may not exceed \$ 55,000 unless otherwise amended; and Paragraph 7, Cost and Delivery of Purchased Services is amended as follows: Subject to the limitations specified in Article 3 and as detailed in the Exhibits, the amount to be paid for such purchased services for each month of services shall be based upon the Agency's Social Service Random Moment Study or at \$.40 per mile for transportation in a vehicle authorized by the Agency. The Agency shall under no circumstances charge fees directly to eligible individuals, or their families, or their custodial parents for services provided under the terms of this contract. All payments made to the Agency shall be for reimbursement of actual expenditures. Agency will provide Department with their quarterly SS-RMS reconciliation. Exhibit A is rescinded and replaced by Exhibit A attached, with this amendment retroactive to August 20, 2009. Vote: Ogle, yea, Walker, yea.

**PRC PLAN:** Motion by Sandy Ogle and seconded by John Walker to pass the following Resolution: We, the Board of Hocking County Commissioners, hereby approve the Hocking County Prevention, Retention and Contingency (PRC) Program Plan. We also certify that the Hocking County Department of Job & Family Services complied with ORC Chapter 5108 in adopting the statement of policies for the Hocking County PRC Program that is effective August 17, 2009. The agency provided the public and local government entities with a thirty (30) day comment period on the Hocking County PRC Plan. Vote: Ogle, yea, Walker, yea.
