COMMISSIONERS MEETING NOVEMBER 24, 2009

The Board of Hocking County Commissioners met in regular session this 24th day of November 2009 with the following members present Sandy Ogle, Greg Green and John Walker.

MEETING: The meeting was called to order by President John Walker.

MINUTES: Motion by Sandy Ogle and seconded by Greg Green to accept the minutes. Vote: Ogle, yea, Green, yea, Walker, yea.

<u>AGENDA:</u> Motion by Greg Green and seconded by Sandy Ogle to approve the agenda. Vote: Ogle, yea, Green, yea, Walker, yea.

MIKE INGALLS: Mike Ingalls, violin instructor at the Piano Works, asked the Commissioners permission for him and his students to play Christmas Carols in the Courthouse. The Commissioners agreed that would be ok. Greg suggested for them to play after the Courthouse Christmas Caroling on December 23rd.

THELMA FARMER-FARMERS REFUSE: Thelma Farmer with Farmers Refuse addressed the Commissioners about her concerns with the Solid Waste District and the proposed fee increase. She feels that they should only do recycling, which would allow them to operate on the fees they currently collect. She also wanted to correct a statement made by Roger Bail, he said it would be a 50-cent charge for customers, but she said it would actually be more like \$2.00. She concluded by saying that a no vote is not against recycling, it is against the fees, and if they would vote no, they could come up with a better solution. The Commissioners said they were exploring many avenues and that this has opened up many eyes.

NANCY PRIMMER-AMERICAN RED CROSS: Nancy Primmer with The American Red Cross spoke to the Commissioners about a grant for Armed Forces Veterans and their Families. She said that part of what she is promoting is awareness and shared two ideas with the Commissioners. One is a soldiers quilt and the other a flag memorial with each branch of the military represented. The Commissioners suggested Worthington Park as a good place for the flag memorial. They suggested she speak with the Mayor and Harold Wilson concerning these projects. They also suggested she speak with the Veterans office.
