<u>COMPMANAGEMENT:</u> Steve Miller with CompManagement, Safety Coordinator Marjorie Davis, Auditor Ken Wilson, Susan Robinette and Karen Cottrill discussed Workers Compensation options. Steve explained the charge back program option which would require the departments who have a higher amount of claims to pay more and the departments who have a lower amount of claims to pay less. He also explained the new Group Retrospective Plan which is sponsored by CCAO. This program could save the county a projected 13% over a three year period. He also explained that this program does not come without risks. If a member county has a bad year, that will affect Hocking County's rates as well. John feels they should wait until next year to discuss this with the departments. Marjorie thought that they should have a meeting soon to allow the departments to be more proactive.

FOR THE RECORD: Greg arrived to the meeting at 10:57 am.

NICK GATZ, SENATOR VOINOVICH'S OFFICE: Nick Gatz, Senator Voinovich's district representative spoke to the Commissioners about the Senators Connecting Communities Outreach program. This program involves the Senator's Representatives to spend a day in each of the 17 counties. Hocking County's Community Outreach day is Tuesday December 8th. Nick asked the Commissioners what types of concerns they have or what they feel they need help with on a federal level. Greg said they would like the Senator to support the Broadband efforts for our county and support Congressman Zack Space's plan in whole. John said that there has been one thing after another with the broadband issue and has taken too long. Sandy said they are concerned about the Extension Program restructuring and how it will affect 4-H. Nick asked if they anticipate any appropriation requests for next year. Greg said that it is hard for Hocking County to complete projects of that size because we don't have the money to have the studies and engineering done to have the projects shovel ready when opportunities arise. He said he would like to see easier ways for County's to get money to be ready for infrastructure projects. John said our Sewer Department is a good example because there is no money to do they studies and engineering, but they would like to do some work. Nick asked if many manufacturing jobs have left in the past 10 years and the Commissioners answered yes. John said we may need more assistance with the Brickyard in the future.
