EMA DIRECTOR SUSAN RAUBER: EMA Director Susan Rauber gave the Commissioners an overview of Wednesday's events with the high winds. Approximately 1/3 of the population was without power, but was resolved quickly. She also informed the Commissioners that first responders were given their H1N1 vaccines this morning.

EXECUTIVE SESSION: Motion by Greg Green and seconded by Sandy Ogle to enter into Executive Session at 10:32 am with EMA Director Susan Rauber to discuss personnel. Vote: Ogle, yea, Green, yea, Walker, yea.

EXIT EXECUTIVE SESSION: Motion by Greg Green and seconded by Sandy Ogle to exit Executive Session at 11:04 am, no action taken. Vote: Ogle, yea, Green, yea, Walker, yea.

AUDITOR KEN WILSON-GENERAL FUND BUDGET: Auditor Ken Wilson gave the Commissioners an update on the General Fund Budget. He explained that the county is doing better this year than what was anticipated, but a deficit of over \$900,000 is estimated for next year. He suggested to the Commissioners that they look at any uncollected fines or fees that could be collected. John said he feels Indigent Defense needs to be monitored more carefully. Ken said in order to balance the budget, the county would need to make an additional 13% cut on top of the 8% already cut. He said he feels to request another 7% for the departments to cut would keep the carryover balance at a comfortable amount. The Commissioners discussed looking at what is mandated to provide, and look at scaling back what is not, like Fairboard and OSU Extension. Ken suggested to also see if some of the other outside agencies have a carryover balance that would cover their department, so they would not have to ask the Commissioners for an advance, like many departments do. The Commissioners decided they would request the General Fund Departments to cut an additional 7% from their budget for 2010 and stress to collect any outstanding revenue. Ken also informed the Commissioners about the Sewer Fund. He has been in contact with USDA Rural Development concerning the annual report. He explained that there was suppose to be a certain amount of money set aside for each loan into a Reserve account. The money had never been set aside, but has just gone into the carryover balance. Ken said that all they needed to do is transfer the money to a new fund and that would rectify that situation. But he said one thing they discovered was that the sewer fund is not collecting enough to pay the principal and interest on one of the loans. Greg said he feels they should work with Le-Ax for Haydenville and Old Straitsville Water for Rockbridge when the water project is complete, to contract with them that if a customer is delinquent on the sewer bill, their water will be shut off.

<u>BILL ACTION</u>: Motion by Sandy Ogle and seconded by Greg Green to approve the county bills and Then & Now Purchase orders dated December 11, 2009 totaling \$87,139.42 and the EMS bills dated November 16-30, 2009 totaling \$5,054.12. Vote: Ogle, yea, Green, yea, Walker, yea.

RECESS: The meeting recessed at 12:23 pm.

RECONVENE: The meeting reconvened at 2:03 pm in the EMA Conference Room.

GENERAL FUND BUDGET MEETING: The Commissioners met with General Fund Department Heads to discuss the budget. Greg started by saying that over the years, the county has had flexibility with the budget, but we will have to take steps to decrease expense and increase revenue. Sandy said she appreciates all the work that has gone into keeping costs down. John said everyone's work has helped make this year turn out better than projected. Greg said we need to find any way possible to increase revenue, suggested sending letters for delinquent fines or fees. He said the Commissioners have made adjustments to the Health Insurance that will help make a difference. Auditor Ken Wilson gave an update on the General Fund. He explained the deficit for 2009 will be around \$219, 508 instead of \$962,606. But for 2010 a 19% cut is needed to balance the budget. John said the Commissioners would like to only cut \$450,000 into the carryover, so they asked for an additional 7% cut from the departments. He continued to say that they will be looking into the non-mandated costs, and those areas will likely see a larger cut. He explained that they are looking at Workers Comp chargebacks for 2010 which should help the general fund. Prosecutor Laina Fetherolf said that she cut more than 8% the first time and wanted to know if she had to cut an additional 7% on top of that, or if it just had to total 15%. The Commissioners told her that they want a total of 15%, but this could still change. They said they want to continue to have the meetings with the department heads. Connie Steward with Juvenile Court said that she appreciates having the monthly meetings to better understand what is going on and also appreciates that the Commissioners are recognizing the departments efforts to cut costs. Regional Planner Audie Wykle asked if there is flexibility for adjusting office hours and if the Commissioners can decide to close the courthouse for everyone to close on the same day. The Commissioners said they would have to look into it. Greg said that at this point it comes down to personnel. Laina said that if they decide to do Furlough days, it would be easier for her office for everyone to be furloughed at the same time, she asked Ken if that would be easier for his office to process, he said it would be the same amount of work either way. Resident Mike Nihiser mentioned that if they were considering having different office hours for each office, that wouldn't be convenient for the public. John said they will have to look at it. Ken said there would have to be coordination with all of the offices. Mike asked about delinquent real estate taxes, Laina said they are foreclosing on properties. John told everyone to have the revised budgets turned back in by Wednesday December 16th. The next meeting was set up for December 29th at 2:00 pm in the EMA Conference Room.
