<u>FEATHERS ROAD DECISION:</u> The Decision concerning the Petition to Vacate Feathers Road commenced at 11:00 am.

MOTION TO VACATE PETITIONED PORTION OF FEATHERS ROAD: Motion by Greg Green and seconded by Sandy Ogle to uphold the Township Trustees petition to vacate the remaining portion of Feathers Road.

<u>DISCUSSION:</u> Sandy said that this situation is unusual and this road vacation is different from ones in the past. She said she would like to vacate the road pending the road being relocated where Mr. Nihiser has his private road. Engineer Bill Shaw said that anyone could petition for a road to be relocated. Sandy added that this will not devalue Mr. Nihiser's property. Greg said that there is no written policy, only past practices, but no written policy. He continued to say that they have look at each situation closely and make decisions that won't put a burden on the township or the public. Greg added that he feels Mr. Nihiser has put the burden on himself and that usually roads are brought up by the developer. John asked if Greg wanted to amend his motion to add the stipulation that the road be relocated. Engineer Bill Shaw noted that the developer wants to build driveways where he wants them, no matter what. Currently there are two driveways that they have issues with, if the road is vacated, they will have more. He added that the landowners can petition to relocate the road and once relocated then the old portion could be vacated. Mike Nihiser said that a hearing had already been held and it sounds like testimony is being taken today and objects to all of it Greg told Mike that he sent a letter after the hearing and expressed his comments. John said that they asked the Engineer to be present and they were discussing a question with him. Mike repeated a quote from Planning Commission member Bill Kaeppner that was said during the hearing and was later quoted in Mike's letter to the Commissioners. Greg's original motion still stands without amendment. John declared the motion dead due to lack of second. The discussion continued concerning the possibility of relocating the road and that would be a new situation that would require advertisement.

BUDGET DISCUSSION: The Commissioners discussed the Commissioners and Maintenance budget.

RECESS: The meeting recessed at 11:52 am.
