SUSIE O'BRIEN:

Susie O'Brien with the Ohio Secretary of State discussed with the Commissioners the updates on the Board of Elections. O'Brien praised the Board of Elections for such an amazing job on the security upgrades, and for using the funding wisely. O'Brien mentioned more funding being available from federal, with restrictions. The Commissioners discussed the changes that took place during the past election due to COVID restrictions, and upcoming procedures for the election. O'Brien said that there will be in person voting, early voting options, as well as mail in. Federal money coming in for the Board of Elections will allow the office to purchase equipment that will help assist in the absentee ballot process. This could be envelope cutters, specific folders, or perhaps a stuffer to help. Commissioner Waugh asked if the voting registration is being updated. O'Brien replied yes, there are groups and letters sent out that try to find inactive voters, and address changes.

MAJOR CALEB MORITZ:

Major Caleb Moritz presented to the Commissioners 2 orders of business. The first order of business is vacant property behind Kroger, Dairy Queen, and Hocking Valley Hospital. This property is owned by the Commissioners and is being occupied with a homeless camp. Major Moritz told the Commissioners that they police have had to visit numerous times, as well as local businesses and cars are being broken into. Major Moritz recommends no trespassing signs be put up, a 7-day notice for the occupants to clean up their belongings, and for a clean up crew to go in after the week to clean up the area.
