AUDITOR:

Auditor Ken Wilson discussed budget with the Commissioners. Wilson provided a hand out to the board regarding CARES Act monies, some approved and disapproved claims, and how the monies was divided to each local government. Each local government would pass a resolution accepting the money, or they could deny. More help may in future, but it is still not certain.

Commissioner Ogle asked Auditor Ken Wilson what the carry over looked like and Wilson replied it's not as large as last year, but it would keep the County out of watch status. Commissioner Ogle asked for clarification on rather monies spent would be distributed back into each departments line item. Wilson replied that any money spent outside of normal budget for supplies would be reimbursed upon request to that line item for each department.

Commissioner Waugh asked if there were any questions. Grant Coordinator Gretchen Gregory asked Auditor Ken Wilson if there was a better understanding of sales tax lost. Wilson replied that sales tax is behind two months for the reported month, so the current numbers show a loss of 11-12% but further shutdowns could impact that sales tax loss even more.
